- Consideration of the amendment to Article 2: Construction of Language and Definitions, Section 2.20: Definitions, to define Distribution /Fulfillment Centers, Truck Terminals and Warehouses.
- Consideration of the amendment to Article 26: I-R Industrial District Restricted, Section 26.50: Special Uses, to add as a special use, Distribution/Fulfillment Centers.
- Consideration of the amendment of to Article 27: I-1: Industrial District, Manufacturing/Servicing, Section 27.40: Special Uses, to add as a special use, Distribution/Fulfillment Centers.
- Consideration of the amendment to Article 34: Village Form-Based Code Overlay Zone, Section 34.40: Development Standards, to allow accessory buildings in the Village Core Area and eliminate the site plan and special use approval process.
- Consideration of the amendment to Article 49: Requirements for Special Uses, to add Section 49.300, to include specific criteria for special use exception approval for Distribution/Fulfillment Centers.
